#### **NEW BUSINESS**

- Change of Bank MOTION: Jenny "to open 2 new chequing accounts at Stellar Vista Credit Union in Greenwood; one for general funds and one for gaming funds, with separate cheques for each account and with current authorized signing authorities remaining the same." Second: Tessa. Carried.

- Gaming Grant/BCeID Gaming is changing the online platform for grant applications and is
  requiring associations to register for a BCeID. Tanya will contact gaming to confirm if this also
  applies to PACs and the specific PAC gaming grant we apply for, and if so, whether it needs to be
  registered under the school or PAC.

- Wednesday Meetings a PAC executive member is wondering if we can possibly move our meetings to another day of the week. Will try Mondays.
- Bus Cameras Becky Lindquist and Raylene Tyssen discuss getting cameras on our busses for the 4 routes we have in the West Boundary, with emphasis on the Rock Creek/Bridesville bus. They have been documenting cases of vehicles illegally passing the bus and find it happens at least once or twice a week repeatedly. Very concerned about children's safety. They have reasearched some cameras and a company from Abbotsford that specifically sells and installs them for school buses. They are \$3500 each, not including installation. Trustee, Mark Danyluk, suggested they come to the board meeting on April 15<sup>th</sup> and present this to the school board/trustees.
